

### FINAL PROVISIONS

Besides the fees in this Decision, the Bank can charge and collect to the client fees from FINA, CNB, Money Market, as well as other entities, depending on the particular job and its realization.

With fees and certain services, the Bank can charge the actual costs, as follows:

- postage and telecommunications
- costs charged by other banks in the country and abroad
- tax, taxes and similar that the Bank pays
- other expenses not specified but are determined by agreement between the Bank and the service user.

Fees under this Decision is contracted variable, so by conclusion of the work in which the fee is charged repeatedly, client assumes contractual obligation under the present Decision on fees, meaning that client accepts all additional amendments to the Decision. For duration of agreed operation the Bank will not charge the client a fee that was not in the Decision on fees in Retail banking at the time of contract conclusion.

Fees listed in items 20.4. to 20.19. will be calculated and charged only for loans contracted after 01.06.2015.

The decision on fees is an integral part of any contract (frame agreement).

Management Board may, depending on its business interests, meaning of work, market conditions, determine different amount of the fee than the amount specified in this Decision.

This Decision is effective and valid since 10.9.2019.
